


New This Week

- Traffic counts are continuing to climb to pre-pandemic numbers






Building Permits – Madison County






Building Permits – Bonneville County






Building Permits – Jefferson County






Building Permits – Bonneville, Jefferson, & Madison Counties

2020 Total Permit by Type









Passengers: Idaho Falls Regional Airport





US Hotel Weekly Occupancy Data







US Hotel Weekly - Revenue Per Available Room











State of Idaho - Individual Income Tax





State of Idaho - Corporate Income Tax






Teton County, Wyoming - Lodging Tax







Average potato prices received by farmers this week








Distribution of Grants by County

Distribution of Grants per County




Distribution of Grants per Industry

Small Business Grants by Industry Type for the Month of May












Traffic Volumes - Bonneville

Average Daily Traffic Volumes for 2020










Average Daily Traffic Volumes for 2020




Comparing Traffic: Ada County








Idaho Falls' average regular gasoline prices with previous year comparison.






Idaho Counties Gasoline Prices


State Gasoline Price Comparison






Electricity Demand- Bonneville Power Administration

Bonneville Power Administration Weekly Electricity Demand (MWh) June 12 - June 18








PacifiCorp East Weekly Demand (MWh) June 12 - Jun 18






