Weekly Initial Unemployment Claims

Definitions

An **initial claim** is a claim filed by an unemployed individual after a separation from an employer. The claimant requests a determination of basic eligibility for the UI program. When an initial claim is filed with a state, certain programmatic activities take place and these result in activity counts including the count of initial claims. The count of initial claims for unemployment insurance is a leading economic indicator because it is an indication of emerging labor market conditions in the country. However, these are weekly administrative data which are difficult to seasonally adjust, making the series subject to some volatility.



Idaho County Unemployment Rates June 2020




- Madison County had the lowest percentage unemployment rate in the state in April, May & June.
- Jefferson & Bonneville counties are also on the lowest end.
- Blaine County had the highest rate in April, second highest in May, and third highest in June.

Statewide Continued Claims




 Statewide continued claims continue to drop, though they remain significantly above pre-pandemic levels.

 Continued claims peaked at the beginning of May and have dropped every week since.



Unemployment Claims By Industry




Statewide Initial Claims by Industry

Job Openings 5 day Moving Average and Total COVID-19 Cases


- A measure of the 5 day moving average for the total job openings in Idaho against new COVID-19 cases and cumulative COVID-19 cases.

Average Job Openings as Percentage of Population




- An average of the daily job openings as a percentage of the population, by county.

Airport Passengers




Air travel was hit hard by COVID-19. The number of passengers dropped 51% in March, 96% in April, and 89% in May, compared to the previous year.


New Business Applications

- Since then, it is typically trending slightly above most previous years.




Building Permits – All 3 Counties 2020



- Looking at our three main eastern Idaho counties, from tracking permits there has been no clear trend when comparing 2019 permits apart from normal seasonality
- Construction continued due to it being deemed essential in Idaho
- These areas did not have high case levels of COVID-19



Building Permits – Blaine County



- Unlike most counties in Idaho, Blaine County did see a significant drop in building permits compared to 2019
- Blaine County had the highest amount of cases of COVID-19 in Idaho
- After 5 weeks, after initial drop, building permits went back up to normal levels




Social Media Polls


Social Media Stimulus Check

Social Media Poll Comfort Levels




People were the most comfortable going out in public the first week of June then the comfort level began to drop again.

Employment Change since COVID-19 and stay at home order in March




 Throughout COVID19, unemployment has occurred but many continue in the same job or have been rehired/found a new job.




Social Media Poll Consumer Confidence


US Hotel Weekly Occupancy Data

- Due to COVID-19 "stay at home" orders occupancy dropped.
- During March and April many hotels had fewer occupancy because people were staying home.
- Hotels had cancellations.
- As Phase I opening started. Hotel Occupancy continued to raise at a steady pace.
- As COVID-19 had another spike, hotel occupancy % stopped raising.




US Hotel Weekly Daily Rate

- Due to COVID-19 "stay at home" orders, daily rates dropped
- April 1st weekly daily • rates hit its lowest numbers
- As Phase I opening • started. Hotel weekly daily rates continued to raise at a steady pace.
- As COVID-19 had another spike, hotel weekly daily rates dropped.



US Hotel Weekly Data




 Revenue per available room (RevPAR) is a performance measure used in the hospitality industry.

- RevPAR is a metric used in the hospitality industry to assess a property's ability to fill its available rooms at an average rate. An increase in a property's RevPAR means that its average room rate or its occupancy rate is improving.
- Due to COVID-19 "stay at home" orders, occupancy dropped, bringing down Revenue per Available room.
- During March and April many hotels had fewer occupancy because people were staying home.
- As Phase I opening started. Hotel Occupancy continued to raise at a steady pace helping Revenue per Room rise
- As COVID-19 had another spike, hotel occupancy % slowed, lowering Revenue Per Available Room .



Local Small Business Interviews




- This survey was conducted mid-May 2020
- Only 26% of these businesses said they would require masks
- Interestingly, a few months later, we see many more stores now requiring face masks (ex. Walmart, Target etc.)

Business Grants per County




 The number of grants have been decreasing. There was a slight increase mid July but has followed the decreasing trend since.

Grants by Industry (for the week ending)




 The construction industry continues to have the highest grant application rate despite the number of grants plateauing.

Accumulation of Top 5 Crimes in Bonneville, Jefferson, and Madison County (As of the end of June 2020)





- The types of crimes committed did not vary much from pre to post shutdown.
 - Shoplifting has decreased, not surprising as many businesses closed in this time period.

Criminal Activity Comparison of Counties between January and June




- A decrease in criminal activity was observed in every county

 The two years start relatively near each other but diverge once the shutdown was implemented




Traffic Volumes - Accumulation of Bonneville, Jefferson, and Madison


 Shutdown affects the amount demand for gas









Idaho Falls Gasoline Price

At the start of the COVID-19 outbreak gasoline prices dropped all across the country. These charts show the average price trends for gasoline in Idaho Falls.




Gasoline Type Price Comparison
