



## **Definition:**

An initial claim is a claim filed by an unemployed individual after a separation from an employer. The claimant requests a determination of basic eligibility for the UI program. When an initial claim is filed with a state, certain programmatic activities take place and these result in activity counts including the count of initial claims. The count of U.S. initial claims for unemployment insurance is a leading economic indicator because it is an indication of emerging labor market conditions in the country. However, these are weekly administrative data which are difficult to seasonally adjust, making the series subject to some volatility.

#### **Historical Initial Claims**




- As March 2021 comes to an end there has been a small increase in weekly initial claims.

- While Spring 2021 initial claims remain higher than normal, they're drastically lower than Spring 2020 at this point.






- Each county has had a slight increase in its unemployment % from Jan to Feb

## **Traffic Trends**



- February 2021 saw a small increase in traffic counts from January 2021.
- Traffic counts for February 2021 were lower than counts in the same month for 2018 and 2020. Counts were slightly higher than 2019.
- It will be important to keep an eye on March and April to see if counts increase like previous normal years or if they decrease. Bonneville county will be important to watch with the current Covid-19 cases increase.






#### Idaho had the 3rd lowest active listings when tracking began in July of 2016 but now has the 2nd lowest amount of listings



 Percentages shown the icrease in Median Listing price from Feb 2017 to Feb 2021





#### Mortgage rate trends





## **House Price Index, Neighboring States**




Compared to neighboring states, Idaho Is slightly above the national average but below the majority of the neighboring states.





- Montana had the smallest decrease of 17%














- Universities continue to struggle against Covid, having constant spikes during their initial openings.

• Credit Unions saw a massive spike in assets and Deposits during the second quarter of 2020, but dropped the following quarter.


Banks remained stable throughout the year.

Despite Credit Unions having a spike mid-2020, in total assets and deposits, Banks continued to have better averages than Credit Unions.





#### INTERSTATE DRIVERS LICENSES AND I.D. CARDS SURRENDERED (ACTUAL COUNT BY YEAR)




## **Drivers License Migration to Idaho by Age**
