

Idaho Lodging Taxes Collected


- The amount of lodging taxes collected increased annually until the fiscal year of 2020, when it decreased by 4.9%.
- The lodging taxes collected in the first two quarters of 2021 outperformed the average of the previous five years.





Idaho Lodging Tax Seasonality


- Lodging tax revenues peak in late summer, during the month of August.
- Apart from a small rise in March, the winter months remain low in tax revenue.





Idaho Health Insurance

- The health insurance uninsured rate reached a peak of 19.1% in 2010.
- From 2015 to 2019, the uninsured rate in Idaho was stable at around 10%-11%.








Idaho Energy Production

Idaho produces approximately 32% of the total energy it consumes, including electricity, transportation fuels, and heating fuels. The State's reliance upon imported energy requires a robust and well-maintained infrastructure of highways, railroads, pipelines, and transmission lines to facilitate economic development and maintain Idahoan's high quality of life.




Total Idaho Energy Production

Idaho Energy Consumption by Sector





Labor Underutilization


- Traditional unemployment (U-3) along with U-6 unemployment, which accounts for marginallyattached workers and part time workers for economic reasons
- In both cases, Idaho has far lower unemployment rates than the national average

Labor Underutilization (Q3 2020-Q2 2021)




Leisure and Hospitality

- Leisure and Hospitality is one of the most affected industries from the pandemic.
- Saw about a 36% decline from March to May 2020.
- Idaho Falls has made almost a full recovery in employment from the beginning of the pandemic.






Population Changes in Eastern Idaho


Population Changes in Eastern Idaho





Graduation Rate

 Idaho's high school graduation rate rose to 82.1 percent in 2020 amid a worldwide pandemic that closed most high schools during the final two months of the school year.



Multiple student demographic groups showed increases, including migrant students (up 6 percentage points to 70.3 percent) and students who are homeless (up 3.9 percentage points to 61 percent).


- The four-year graduation rate for Hispanic students increased by nearly 2 percentage points from 73.9 percent to 75.7 percent.
- The rate for economically disadvantaged students increased by 1.3 percentage points from 72.5 percent to 73.8 percent.
- The rate for students with disabilities increased by nearly 3 percentage points, from 56.1 percent to 59 percent.

Unemployment in Eastern Idaho


 Most counties in the region have similar rates, except
